Alaska Railroad announces promotions and transfers throughout the organization

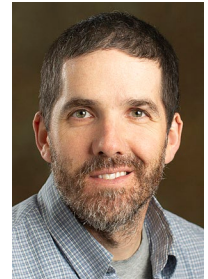

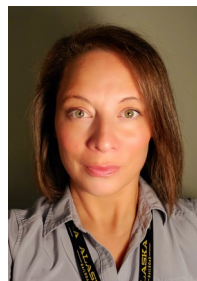
